This is for the information of all concerned that in the meeting of HODs and members of admission committee held on 25.07.2018 it is resolved that those students who have taken admission into 1st year of +3 Degree course in Arts/ Science/ Commerce streams during this session 2018-19 against reserved seats (quota) meant for Physical Handicapped category students by submitting fake/forged **disability certificates** be immediately intimated through notice (College Notice Board & college Website) to explain why their admission will not be cancelled and any other disciplinary action including criminal proceedings shall not be initiated against them. If no reply is received from them within the stipulated period actions as deemed fit will be taken at this end against them.

Therefore, the following students who have taken admission against reserved (quota) seats meant for Physical Handicapped category students by producing fake/forged disability certificates (as reported by CDMO, Puri after due verification at their end) at the time of admission are hereby **directed to explain in writing to the undersigned within 03 (three) days positively why their admission will not be cancelled and any other disciplinary action shall not be initiated against them as they have already given undertaking in their Common Application Forms (CAF) to the effect that any wrong/false information provided by them and detected later will be considered as cognizable offence.**

If no reply is received from any or all of the above mentioned candidates within the stipulated period actions as deemed proper will be taken against them at this end.
