(A) College, Puri payable in any nationalised bank located at Puri and after receipt of the same order will be issued in his/her favour to carry out the work. The selected bidder has to bear the expenses for determining/ ascertaining the weight of the scrap material.**

The auction papers in sealed cover will be received by the office through registered/ speed post only from **01.12.2021 to 06.12.2021 till 4.00 P.M.** after which auction paper will not be entertained. The sealed covers of the auction papers will be opened and comparative statement will be prepared by the officials/ purchase committee members of the college at **3.00 P.M. on 13.12.2021.** The bidders or their authorised agents may remain present in the college office on the schedule date and time of opening of the sealed auction papers, if they so desire. It may be noted that the sealed auction papers will be opened on the scheduled date/time even if no representatives of the bidders are present.
