**RE-ADMISSION NOTICE**

As per this office order No. 2591/ Dtd. 17.09.2024 & 2694/ Dtd. 24.09.2024, the date for collection of Re-Admission fees was given from 17.09.2024 to 24.09.2024 and 24.09.2024 to 27.09.2024. After considering the grievances of various students the last date of collection of re-admission fees is **extended up to 01.10.2024**. The students are advised without waiting for the last date deposit the fees in advance. Students having inadequate percentage of attendance are required to contact their HODs for arrangement of extra-classes for attending the requisite percentage of attendance for promotion to the next higher class. Otherwise, students will not be allowed to appear the examination.

**Steps to pay Re-admission Fees Online**

- i) Visit the college website <http://scscollege.nic.in/>
- ii) Click on payment gateway on the homepage (you will be directed to payment gateway)
- iii) Or Click on the link:

- iv) Enter the College Roll Number.
- v) Fill the particulars asked (Individual/ Name/ DOB/ Mobile No/ E-mail Id/ Captcha Code etc.)
- vi) Pay through any available mode.
- vii) Take a print out of payment receipt or take a screenshot keep it for future reference.

**Exemption**

- i) As per Govt order No. 1829/ Dt. 19.01.2018 and No. 44034/HE, Dt. 19.10.2022, the students of UG Arts (Odia Honours) are exempted from payment of re-admission fees.
- ii) As per Govt. Order No. 33498/HE, Dtd. 06.08.2022 students covered on Green Passage Scheme are also exempted from payment of re-admission fees.

However, the exempted category students are required to report in the Academic Section during the scheduled dates for renewal of their candidature for the session 2024-25.
